## Brothers and Sisters.

As we reported to you on Wednesday, Feb. 3, NATCA decided after very careful consideration and many provisions in the bill that protect the workforce to support the FAA Reauthorization bill introduced by House Transportation and Infrastructure (T&I) Committee Chairman Bill Shuster (R-PA-9), titled the Aviation Innovation, Reform, and Reauthorization Act of 2016 (H.R. 4441, the AIRR Act). The bill proposes a change to the funding of the National Airspace System (NAS) and would separate ATC operations of the NAS from the safety and regulatory functions at the FAA, while protecting our members' rights, pay, benefits, and retirement. It would provide a solution to the current problem of an unstable, unpredictable funding stream to operate and improve the 24/7 safety function we provide.

On Wednesday, Feb. 10, the House T&I Committee <a href="held a hearing">held a hearing</a> to review air traffic control reform proposals. Witnesses included NATCA President Paul Rinaldi, Airlines for America President and CEO Nicholas Calio, National Business Aviation Association President and CEO Ed Bolen, and Reason Foundation Director of Transportation Policy Robert Poole. Paul's <a href="testimony">testimony</a> was received with tremendous respect on Capitol Hill. While members of Congress may disagree on some of the policy considerations in the proposal, we have received positive feedback from numerous members of Congress and Congressional staff expressing that Paul effectively articulated NATCA's concerns with the status quo: how the stop-and-go funding stream has had a negative effect on the system, and how workforce protections are maintained in the proposed legislation. We believe that an important highlight of the hearing was when Ranking Member DeFazio (D-OR-4) pointed out that, in all his years in Congress, he had never seen a piece of legislation that was so comprehensive in terms of worker protections.

Yesterday, Feb. 11, the House T&I Committee <a href="held a markup">held a markup</a> of H.R. 4441, passing the legislation by a vote of 32-26, moving it to the floor of the House of Representatives. There were more than 90 amendments filed for consideration during the nine-hour markup. Ranking Member DeFazio offered a targeted amendment to provide a stable funding stream for the FAA. As promised in our original email, we thoroughly reviewed Mr. DeFazio's amendment and found his amendment would satisfy our requirements. As a result, we supported it. However, his amendment failed by a vote of 25-34.

NATCA closely monitored the entire markup, carefully reviewing amendments as they were being considered, and working with members of Congress and staff on behalf of our membership. The next step for the bill is to receive a vote in the House of Representatives, and the timing is uncertain. This process is very fluid, and we will continue to keep you updated.

We understand that this is a complex, important issue, and you may have questions. We want to answer them, provide you with information about this legislation, and the reasons for NATCA's support.
