President Santa called the virtual meeting to start at 10:00 am EDT on June 26, 2024.

Opening Remarks (Rich Santa, President)

Bipartisan Infrastructure Law (BIL) Brief (Rich Santa, President)

Anthony Schifano (CLT), Joe Peterson (ENM), and Steve Leininger (RDG) joined the NEB virtually to provide a brief overview of the BIL Workgroup achievements, status, future goals, and requested guidance on how to proceed moving forward.

After discussion, Anthony and the BIL tower design subgroup will work with the NATCA Chief of Staff to develop a path forward that provides for oversight on the construction of towers resulting from the BIL design.

Article 114 vs LR Appointment (Rich Santa, President)

President Rich Santa and NGL RVP Drew McQueen updated the NEB on the reported concern of a full-time Article 114 NATCA Representative also acting as an Offsite FACREP. The NEB discussed official time vs. duty time and the importance of scheduling both to ensure they do not overlap.

After discussion, the NEB approved Erin Phelps to serve as the Offsite Facility Representative of the RST (Rochester International Airport). with EVP LeBovidge not present.

The NEB also approved Karena Marinas to serve as the Offsite Facility Representative of the Molokai (MKK) Federal Contract Tower in Hawaii, with EVP LeBovidge not present.

NATCA Academy Expense Reimbursement Spreadsheet (Nick Daniels, NSW RVP)

The NEB approved the Academy Expense Reimbursement Spreadsheet as the ATX guideline and agreed to add it to the NATCA website, with EVP LeBovidge not present.

Charlotte Tower (CLT) Runway Safety Lights Briefing (Dan McCabe, NSO RVP, Anthony Schifano, NATCA CLT Representative, Chris Riddle, NATCA Local CLT, Allison Mattioli, NATCA Local CLT)

Anthony Schifano (CLT), Chris Riddle (CLT), and Allison Mattioli (CLT) joined the NEB virtually and provided a brief status update on the current concerns and issues regarding the CLT Runway Safety Lights System for the new runway. Currently, the Runway Safety Lights System has been removed from the construction plan due to funding cuts. An SRMP was previously conducted, and the panel members assessed that the Runway Safety Lights System is necessary due to safety risks.

The Mayor of Charlotte, North Carolina, has been informed of the concerns and the assessed risk if the CLT Runway Safety Lights System is not funded and implemented in the construction of the new runway, with hopes that the mayor will reconsider funding the safety system.

After discussion, the NEB has agreed to address the issue on a global level.

National Benefit Committee (NBC) (Brad Davidson NRX RVP, Jennyfer Rivera (ZID) NBC Chair, Molly Kent (ZSU) NBC Co-Chair):

Jennyfer Rivera (ZID), NBC Chair, and Molly Kent (ZSU), NBC Co-Chair, briefed the NEB on a new member benefit. The proposed benefit, called Passport Health, offers travel medical services including necessary vaccines and medical services for international travel. Members would incur out-of-pocket expenses which could be submitted to their current insurance provider

for potential reimbursement. However, reimbursement is not guaranteed and depends on the insurance provider, with roughly a 50/50 chance if members choose to utilize this service.

The NBC aims to receive NEB guidance by the next NEB meeting.

The NEB will review the Passport Health website and be prepared to vote on and provide guidance at the upcoming NEB meeting.

NBC Retirement Seminars Proposed Locations for 2025 from the RVPs.

The NEB will provide the NBC with Retirement Seminar Proposed Location for 2025 during the August NEB Meeting to ensure any NEB Officers that may change during the July 2024 elections can be involved in the location decisions.

During discussion the NEB confirmed with the NBC that a virtual option will be available. The NEB will work with Chief of Staff to be able to send out the virtual Retirement Seminar nationally.

NBC Member Solicitation for Additional NATCA Member(s) (Brad Davidson NRX RVP)

The NEB discussed and agreed to send a national solicitation for three additional NBC members.

Garett Teams (ZDC) for Professional Standards (PS) Virginia (VA) Chair (Brian Shallenberger, NEA RVP)

The NEB approved Garett Teams (ZDC) to serve as the Virginia (VA) Professional Standards Chair, with EVP LeBovidge not present.

Status of the Grievance Automated Tracking System (GATS) Replacement (Brad Davidson, NRX RVP, President Rich Santa, Dean Iacopelli NATCA Chief of Staff)

Chief of Staff Dean Iacopelli spoke with Nicole Vitale (NATCA Director of Labor Relations), the Grievance Review Team (GRT), and Jason Doss from the IT Committee regarding the status of the GATS replacement. Currently, we are waiting for the system to be updated with management email addresses. Jason Doss anticipates that the addresses will be populated into GATS within the next couple of weeks. He also reported an issue with permissions that the IT Committee is working to resolve. However, if a 30-day deadline is set, he is confident that the IT Committee can meet it.

RVP Nick Daniels has an IOU regarding the GATS system permissions since he is currently the only person with the permissions to complete the full grievance process online.

Article 114 Update (Dan McCabe, NSO RVP)

RVP McCabe updated the NEB that a couple of Article 114 Representatives have reported occasional lapses in communication from their counterparts. This is for awareness purposes, and no action is required at this time.

National Training Committee (NTC) Update (Nick Daniels, NSW RVP)

RVP Nick Daniels briefed the NEB that the NTC is currently at risk for being over budget for this year's training. The committee is exploring options to make recommendations for adjustments.

The Leadership Experience Acceleration Project (LEAP) in Warrenton, VA, scheduled for October 2024, had to be pushed back one week due to instructor availability. The new proposed dates are October 28 to October 30, 2024. The NEB approved the date change, with EVP LeBovidge not present.

RVP Nick Daniels advised the NEB that the NTC intends to look for an alternate location for the 2025 Virginia LEAP training because this year's numbers show a \$32,000 difference between locations for lodging and training.

RVP Nick Daniels also confirmed that the NTC is working on the 2025 Training Schedule and will coordinate with the Chief of Staff on securing the estimated costs for the training, as soon as possible.

Committee Chair Meeting Update (Clint Lancaster, NAL RVP)

RVP Clint Lancaster informed the NEB that the Committee Chair Meeting is scheduled for January 28 (half day) and January 29 (full day), 2024. The meeting location is still being determined, Denver and Chicago are being considered. The NEB will reassess the January dates during the August NEB meeting to ensure they are suitable for NEB members after the election concludes.

National Employees Services Team (NEST) workgroup (Mick Devine, NNE RVP)

Michael "Danny" Watson (NEST Lead, NATCA ZAB Representative) and Todd Mariani (NEST Co-Lead, NATCA ZKC Representative) briefed the NEB on refining the NEST Standard Operating Procedure (SOP) proposal based on feedback from the April 2024 NEB meeting.

The NEB discussed the proposal and requested more time to read and digest the proposed SOP. The NEB will be prepared to vote and/or provide guidance at the upcoming NEB meeting.

Communications Committee Update (Aaron Merrick, NCE RVP)

RVP Aaron Merrick reminded the NEB to maintain communication with their Communications Representatives as the Archie League Award winners will be announced soon.

Air Safety Investigations (ASI) Committee Update (Aaron Merrick, NCE RVP)

RVP Aaron Merrick reminded the NEB that a Terminal ASI Committee solicitation for a Mentee and an Investigator was sent to the terminal membership on June 21, 2024.

National Safety and Technology Leadership Council (NSTLC) National Airspace and Procedures Committee (NAPC) Charter (Clint Lancaster, NAL RVP, and Aaron Merrick, NCE RVP)

RVP Clint Lancaster and RVP Aaron Merrick briefed the NEB on the NSTLC's proposed recommendation to amend the NAPC charter to align with FAA program priorities, funding, and the implementation of Service Center SOPs for Airspace Modernization. The proposed changes include removing the Trajectory Based Operations (TBO) and Navigation Article 114 Representatives and adding the three Operations Support Group (OSG) and the three Instrument Flight Procedures (IFP) Article 114 Representatives.
