Discussion about AJ submitting claim request for downed sections of fence from storm, and that there is no conflict of interest if the claim is submitted and processed in the same manner as any other member. A motion to *"approve the \$630 request for AJ to repair his fence"* was made by Tom, and second by Brett. 5 in favor, o opposed, o abstain. Motion adopted.
- 6. Woody to initiate a T shirt fundraiser to go live approximately June 19, 2024.
