 - o Same numbers as 2024 have been submitted for 2025
 - o Marriott AFL-CIO code 1016814
 - o Buget line 27 in Concur
 - ATX Line 91 to cover for four presenters

 - o Potential Charter Amendment Reference two RVPs required
- Regional Reviews
 - o NAL
 - ✓ In-person onboarding accompanied by a facility visit with RVP when possible.
 - o NCE
 - ✓ Five FAA, three FCTs in 2024. Looking to streamline FCT process.
 - ✓ Typically accompanied by a facility visit with the RVP.
 - ✓ Tracking regional resources who are in contact with the reps and ongoing issues via Google Forms.
 - o NEA
 - ✓ PowerPoint for all onboarding.
 - ✓ District leadership breakdown provided to the reps.
 - ✓ Most done virtually.
 - ✓ In the process of building an Onboarding team (a lot of turn-over).

- ✓ Creating election tracking through excel to auto-send messages to reps about impending elections.
- o NGL
 - ✓ Eight in 2024.
 - ✓ RVP desire to do in-person, going to discuss budget.
 - ✓ Incorportated new tracking system and working on PowerPoint.
 - ✓ RVP making welcome video, ARVPs joining day-one call.
- o NNE
 - ✓ Working on establishing onboarding in the region.
 - ✓ Considering breaking up the region into 'North' 'South'.
- o NNM
 - ✓ Many in-person.
 - ✓ Developing a team one person per district.
 - ✓ Looking at different lists for different 'type' facilities.
 - ✓ Loops in other committees if needed.
- o NRX
 - ✓ No update
- o NSO
 - ✓ Going to develop virtual FCT onboarding and group them together by company.
 - ✓ Considering scheduling regional leads during onboarding window for separate mini briefs.
- o NSW
 - ✓ Two virtual in 2024.
 - ✓ Using PowerPoint, plans to potentially update to personalize as needed.
- o NWP
 - ✓ Many virtual and in-person in 2024.
 - ✓ Still working on putting a team together.
 - ✓ Uses PowerPoint for all onboarding.
- Day 1 Guide changes
 - o Create/Download PDF to save in TEAMS to distribute to FacReps.
- Face to Face Checklist
- FCT Briefing/Training
 - Organizing Committee Chair John Bratcher provided an overview of important items to brief FCT Facreps on when conducting FCT Onboarding
 - o RVA (CI Squared), Midwest, Serco
 - RVA has voluntary recognition. Allows to bypass elections and gives auto recognition as a NATCA tower if the majority of the workforce wants to organize.
 - o FCT wages are based on minimum wage determination, so the only way to receive raises is if they have a CBA.

- Serco International company. Used to be openly very anti-union as a company.
 Newer leadership is pro-NATCA. Serco is currently significantly increasing
 NATCA facilities. Serco has a retention problem and are all short-staffed.
- O Three types of people work at FCTs Post-military and waiting to be hired by the FAA, missed the 31 age requirement, or retired FAA (typically short-term because underestimated how much they would work at the FCT).
- o RVA No AL for the first year. Currently fighting SL dispute with DOL.
- o All three have similar CBAs, but not the same.
- Midwest CBA has duty time for Legislative to attend NiW.
- All CBAs contain 3% raise.
- o Voluntary Reporting Program ASAP Safer FCT
- o FAA Reauthorization may allow for bringing some FCTs into the FAA
- Towers are either city owned, by the 'authority', or FAA owned. Serco Midwest and RVA are just 'service providers' (govt contractors).
- o FCT training is two days in DC. Taught by an Organizing Committee member and an LR attorney.
- o Three unions represent FCTs. PATCO AFGE, NATCA, PATCO Inc.
