



Request for Establishment or Change of Voluntary Deduction to the National Air Traffic Controllers Association (NATCA)

"I hereby authorize and direct the Federal Aviation Administration to deduct from my bi-weekly pay, the amount indicated below and forward such amount to the National Air Traffic Controllers Association (NATCA) Political Action Committee (PAC). This authorization is voluntarily made on my specific understanding: that the signing of this authorization and the making of these voluntary contributions are not conditions of membership in or employment by NATCA; that the amounts listed below are only suggestions and that I am free to contribute more, less or not at all without reprisal; that NATCA PAC will use the voluntary contributions it receives for political purposes, including but not limited to making contributions to and expenditures on behalf of candidates for federal, state and/or local offices and addressing political issues of public importance; and that federal law requires political committees to report the full name, mailing address, occupation and name of employer for each individual whose contributions to the PAC aggregate in excess of \$200 per calendar year. This voluntary deduction to contribute to NATCA PAC will remain in force until revoked by me in writing to the Treasurer of NATCA PAC or I am no longer in NATCA PAC's eligible class." **Contributions to the NATCA PAC are not deductible for federal income tax purposes.**

Privacy Act Statement:

Executive Order 9397 allows Federal agencies to use the social security number (SSN) as an individual identifier to avoid confusion caused by employees with the same or similar names. Supplying your SSN is voluntary, but failure to provide it, when it is used as the employee identification number, may mean that the payroll deductions cannot be processed.
